After a discussion, Councilman Markel Whittington moved, seconded by Councilman Buddy Palmer, to remove and table action on 539 Magazine Street and 1606 Eckford until the January 7, 2020. Of those present, the vote was unanimous in favor.

Councilman Markel Whittington also moved, seconded by Councilman Buddy Palmer that the remainder of the demolition list be approved as submitted by the Department of Development Services as being in such a state of uncleanliness and disrepair as to be a menace and hazard to public health, safety, and welfare of the community. By this action, the City of Tupelo was authorized to demolish: 215 South Green Street, 656 Melinda Alley and 1204 Hilda all in the City of Tupelo, invoice the owners, and place liens on the property if the owners do not pay for the demolition. Councilman Markel Whittington moved, seconded by Councilman Lynn Bryan to approve CAP loan in the amount of one million five hundred thousand dollars (\$1,500,000); authorize payment of up to one million five hundred ten thousand dollars (\$1,510,000) for the purchase of land and buildings located at 545 Commerce St from Bellerive Properties/Evan Athanas/Adam S. Mitchell; authorize the Mayor and City Clerk to execute any and all documents necessary to obtain the loan and close on the property; and allow the City Clerk to draw down the CAP loan to repay expenditures.
